Wayne Co. Commission Updated On Ag Center



Progress is being made at the new Ag Center facility at the Wayne County Industrial Park on Highway 13 South. It was reported at the commission meeting that crews are working on the concrete and plumbing for the facility at this time.

The Wayne County Board of Commissioners met in regular session on Tuesday, March 22, 2022. County Executive Jim Mangubat called the meeting to order. Commissioners in attendance were Ricky Kelley, Herbert Brewer, Tim Prater, Phillip Casteel, Tim Powell, Sherrie Powers, David Martin, Kathryn Staggs, John McDonald, Stephen Pevahouse, and Katherine Reeves. Also in attendance were County Clerk Stan Horton and County Attorney Andy Yarbrough. Commission-

ers Vickie Petty, Tom Mathis, and Mary Lauren Garner were absent. Commissioner Kelley made a motion to approve the minutes of the previous commission meeting. Commissioner Prater seconded, and the minutes were approved. Commissioner Kelley then made a motion seconded by Commissioner Staggs to approve the minutes from the various committee meetings, and those minutes were approved as well.

High Winds Damage Homes & Businesses Across County

A major wind event struck Wayne County last Tuesday, March 22, damaging homes and businesses across the county. Toward the end of a day that had already produced heavy rain and gusty winds, either straight-line winds or a near touch-down of a tornado caused fear and damage in the county. Thankfully, no one was reported as being injured during the wind event.

Sometime between 5:00 and 5:30 p.m. on March 22, a windstorm that most people said "came up all of a sudden" caused damage to homes and businesses. Many roofs and sheds were damaged, and trees were blown down in many parts of the county. Highway Superintendent Chuck Moser reported downed trees and debris in the roadways on Herbert Gallian Drive, Old Town Branch, Simmons Branch, Waterfall Road, Hurricane Creek, Upper Green River, and Johnson Hollow Road,

My dad, John McDonald, has been one of the County Commissioners in the 3rd District for the past 16 years and will not be seeking re-election. My dad has taught me a lot about the workings of our local government.

Multiple-Count Indictment Returned In 2021 Death Of Hardin County Deputy

An investigation by special agents with the Tennessee Bureau of Investigation has resulted in the indictment of a Clifton man in the September 2021 shooting death of

a deputy with the Hardin County Sheriff's Office.

On September 26, 2021, at the request of 24th District Attorney General Matt Stowe, TBI agents began investigating the on-duty homicide of Hardin County Deputy Matthew Locke. Deputy Locke was fatally wounded while responding to assist other deputies and officers during a domestic disturbance in the 3000 block of Nance Bend Road in Clifton.

Beavers Tie & Lumber Company seemed to sustain the most severe damage in the storm. Mr. Jim Beavers said that a lumber storage build-

ing, a hay barn, and four out-buildings were destroyed, but his faithful and determined employees worked hard to get most everything cleaned up after several hours' work. Mr. Beavers said that even though the wind was pretty

rough that day, it in no way could compare to the F5 tornado that struck Wayne County on Thursday, April 16, 1998. That day changed many lives forever, killing three and causing more storm damage in the county than had ever been seen before. The path of that tornado came right through Beavers Tie & Lumber, destroying all the machinery and buildings at the business and scattering lumber for miles.

The wind event on Tuesday has not been classified as a tornado, but many believe that it was. WSMV Channel 4 in Nashville reported spotting markers on the radar in Wayne County that could be causing wind damage just before the highest winds hit. Wayne County EMA Director Robert Farris told The News that the National Weather Service is still doing surveys in several counties, including Wayne. He went on to say that several other counties sustained damage, including Lawrence County. "I drove up the Summertown Turnpike on Wednesday," said Farris. "I saw tops twisted out of trees, and that is a good indicator that a tornado came through but didn't necessarily touch down on the ground."

With power out for several hours and trees covering roads, the county road crews and TVEC worked hard to restore power and clear roadways. These crews are greatly appreciated by everyone in the county for their dedication to the job.

School Board Recognizes Athletic Achievements

The Wayne County School Board met in regular session on Thursday, March 17, 2022 at 5:30 p.m. in the Central Office Board Room. Board members in attendance included Andy Yarbrough, Sherman Martin, Charity Horton, Debbie Brown, and Camryn Eaton. Superintendent Marlon Davis was present as well. Board member Dwight Bumphus was absent.

Chairman Andy Yarbrough called the meeting to or-

der and invited those in attendance to participate in a moment of silence and the Pledge of Allegiance.

The first items on the agenda included adoption of the consent items, minutes of the February meeting, and the February ledger of accounts. Sherman Martin made a motion to approve. The motion was seconded by Debbie Brown and was passed unanimously.

The first item under new business was Policy Review:

Section 4 – Instructional Program – 4.100-4.405. Superintendent Davis had no recommended changes to the policy.

One overnight trip was presented to the board for approval: Wayne County Technology Center – FBLA Convention, Chattanooga, TN, April 3-6, 2022. Charity Horton made a motion to approve, and Debbie Brown seconded. The trip was unanimously approved.

next on the agenda for approval. Superintendent Davis presented the following for approval: Spencer Hammond, WCHS Boys' Soccer; Shawon Fisher, WCHW Boys' Soccer; Jason Crews, WCHS Softball; Brian Miller, WCHS Baseball, and JK Staggs, WCHS Baseball. Superintendent Davis stated that Spencer Hammond and Shawon Fisher had satisfactory background checks, and the remaining had background checks pending. Camryn Eaton made a motion to first approve Hammond and Fisher. Sherman Martin seconded, and the motion passed unanimously. Sherman Martin then made a motion to approve the remaining non-faculty coaches pending satisfactory background checks. Camryn Eaton seconded, and the motion passed unanimously.

Surplus property was next under new business. Superintendent Davis presented a list of computers and peripherals from WMS to be declared as surplus. Sherman Martin made a motion to approve, and Camryn Eaton seconded. The motion carried unanimously.

Next on the agenda was the Legislative Funding Bill. Superintendent Davis updated the board on the latest funding bill proposed by the governor and compared the district's current funding to the proposed amount.

Next under new business was each high school's prom. Superintendent Davis said that the high schools are requesting to hold their proms off-campus at the following locations: FHS – Clifton City Park, April 8; CHS – Pleasant View Farms, Iron City, TN, April 22; WCHS – Pleasant View Farms, Iron City, TN, April 29. Charity Horton made a motion to approve the requests, and Camryn Eaton seconded. The motion carried unanimously.

Budget amendments were next. Superintendent Davis presented line-item budget amendments related to General Purpose Special Education and Coordinated School Health. Sherman Martin made a motion to approve the amendments as presented. Charity Horton second, and the budget amendments were approved unanimously on roll call vote.

Initial information indicated that just after 8:30 p.m., deputies with the Hardin County Sheriff's Office, an officer with the Clifton Police Department, and deputies with the Wayne County Sheriff's Office were dispatched to a residence in the Cobb Farm area on the Wayne/Hardin county line in reference to a domestic disturbance. Upon arrival, officers made contact with Todd Alan Stricklin, who was armed with a handgun. Officers ordered Stricklin to drop the weapon, but he refused. As Hardin County Deputy Matthew Locke approached the home to assist, Stricklin shot him. The deputy was transported to a local hospital where he later died.

On March 21, 2022, a Hardin County Grand Jury returned a 23-count indictment against Stricklin (DOB: 12/6/72), which include the following charges: First Degree Murder, Felony Murder, Attempted First Degree Murder (five counts), Possession of a Firearm During the Commission of a Dangerous Felony (five counts), Aggravated Kidnapping, Aggravated Assault (six counts), Domestic Assault, Interference with an Emergency Call, Reckless Endangerment, and Evading Arrest.

Stricklin remains in custody at the Chester County Jail where he is being held without bond.

Hardin County Sheriff Johnny Alexander said about Deputy Locke, "Our country has lost a warrior. Our community has lost a hero. Our department has lost a brother. We will never forget Deputy Locke, and we are all forever in debt for his sacrifice."

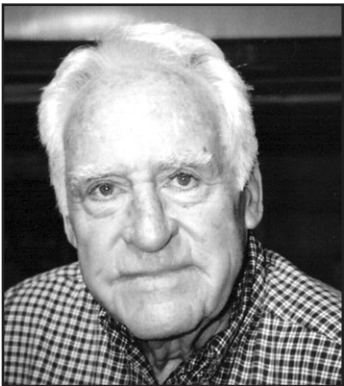

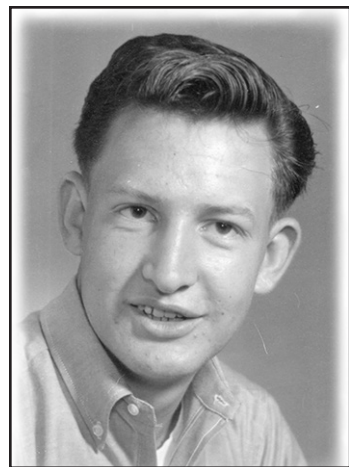

Ask Rusty – Do Immigrants Get Social Security Benefits?

Dear Rusty: I am 90 and a long time Social Security recipient - I signed up at age 62, which I now know was not wise, but I digress. We see from various sources that immigrants, legal and illegal, get Social Security benefits merely by attained age, regardless of contributions. Is that true? Signed: Curious Nonagenarian

Dear Curious: Rest assured that illegal immigrants (or "illegal aliens," "undocumented workers" or whatever one chooses to call them) are not entitled to collect Social Security benefits. It is, however, possible for legal immigrants to collect Social Security benefits if they have individually earned the right to do so, including those who are the legally-present dependent (spouse or child) of someone who is collecting Social Security benefits. By "legal immigrant" I mean those who have immigrated

to the United States and have applied for and received either a Permanent Resident Card ("green card") or who have subsequently acquired U.S. citizenship. It's also possible to obtain an "Employment Authorization Document" which grants a foreign citizen temporary authority to work in the U.S., mainly used by citizens of other countries who work in the U.S. (typically those working for an international corporation which has a U.S. presence). In all cases, however, only legal residents who work, earn, and contribute sufficiently to Social Security from their earnings, or who are a legal dependent of someone who is collecting Social Security, can receive Social Security benefits.

The criteria for Social Security eligibility are very strict and those without legal U.S. residency status are not eligible to collect benefits. Especially on today's social media outlets, we often see uninformed people espousing the belief that illegal immigrants enjoy access to Social Security benefits which is simply not true. That's not to say there are no instances of fraud, but rest assured that those cases are vigorously sought and eventually found

and prosecuted by Social Security's Inspector General's office.

FYI, there is another category of federal benefit known as Supplemental Security Income ("SSI") which has somewhat different eligibility criteria but still requires either legal residency as I've defined above, or another special residency status which defines them as a "qualified alien" (e.g., certain Indian tribes, refugees and those granted asylum, victims of human trafficking, etc.), as defined by the federal government. SSI is, essentially, a general disability benefit for needy seniors, minors, and disabled adults with very little income and very few assets. Federal SSI benefits are paid from the general Treasury, not from Social Security funds, and do not detract from Social Security's finances. SSI is administered by each state, which usually provide other assistance in addition to the relatively small federal monetary

benefit (\$841 per month for 2022).

As you are undoubtedly aware, all U.S. States have separate laws which may provide benefits to all state citizens, regardless of their federal residency status, but that is entirely outside the realm of Social Security and does not affect Social Security's financial structure. To receive Social Security benefits, one must have either earned the right to do so by contributing sufficiently to the program or be the legally present dependent of someone who is (or was) collecting Social Security and meet all other eligibility criteria for the benefit claimed.

Regarding your decision to claim at 62, remember that life expectancy is always an unknown factor and deciding when to claim always includes a large degree of uncertainty. We should all be comfortable knowing for certain that Social Security will be there for us until the end.

TWRA Wild Turkey Research Project On Turkey Openers

The 2022 Spring Turkey season is set to open this year on Saturday, April 2, and the Tennessee Wildlife Resources Agency is asking successful hunters in several southern Middle Tennessee counties for assistance.

This is the final year of a joint TWRA/UT Knoxville wild turkey research project and hunter participation is requested. TWRA personnel will set up sampling stations at various locations on opening day on April 2 and the delayed opening day for Lincoln, Giles, Lawrence and Wayne counties on April 16 from 8 a.m. until 2 p.m.

Hunters who harvest a turkey in Maury, Bedford, Lin-

coln, Giles, Lawrence, and Wayne counties can help the study by bringing their harvest to a listed location to allow samples of skin and internal organs to be taken.

For their effort, each hunter will receive a free hat and neck gaiter. They will also be eligible to win a shotgun in a drawing held after the April 16 date.

Ag Day on the Hill celebrates Tennessee's No. 1 industry - Tennessee Ag Day on the Hill was celebrated March 22 on the Beth Harwell Plaza and highlighted the importance of the state's agriculture industry. Among those in attendance were Tennessee farmers, agriculture officials, legislators, Tennessee College of Applied Technology students, 4-H and Future Farmers of America members. The event coincides with National Agriculture Week and recognizes the farmers and forestland owners who are dedicated to feeding, building, clothing, and fueling our nation. It featured livestock, producers and exhibitors from across the state.

New education funding formula advances - The action on Capitol Hill began to shift from committees to the House floor this week as lawmakers worked hard to get bills approved as committees wind down. Standing committees completing their work for the second session of the 112th General Assembly include the House Transportation, Agriculture and Natural Resources, and Insurance.

Discussions continued this week about Gov. Bill Lee's proposed Tennessee Investment in Student Achievement (TISA) program in the House K-12 Subcommittee. The proposal, House Bill 2143, advanced to the House Education Administration Committee with three amendments. Among them is an amendment that changes the weighted funding component for charter schools to a direct funding line. House Bill 2143 establishes the TISA as a new funding model that prioritizes the individual needs of students rather than relying on ratio components and district averages. The plan puts direct focus on students with disabilities, students in rural and urban areas and low-income families. Beginning in the 2023-24

school year, the TISA would invest an estimated \$9 billion in education funding for the state, including state and local funds, which would include an additional recurring state investment of \$1 billion. House Bill 2143 is expected to be heard by the House Education Administration Committee on March 30.

Medical marijuana bill advances - The House Health Subcommittee advanced legislation this week to legalize medical marijuana in Tennessee. House Bill 2641, as amended, would allow qualified patients to use and possess certain forms and amounts of medical cannabis in the state.

The amount of cannabis a qualifying patient could have would not be allowed to exceed 3 grams of Delta 9 tetrahydrocannabinol (THC) in a concentrated product or 3,000 milligrams of Delta 9 THC in infused products. Recreational use of marijuana would still be prohibited. The Tennessee Medical Cannabis Commission would also be required to create and maintain a secure online database for qualifying patients, designated caregivers and qualifying physicians, according to the bill. The registry must be accessible to law enforcement as well as qualifying physicians to verify patient authorization. House Bill 2641 will now go to the full House Health Committee for additional discussion.

Republicans limit big tech censorship of social media users - Republican legislation to further protect Tennesseans' freedom of speech on social media advanced out of the House Commerce Committee on Tuesday. House Bill 2369, as amended, would prohibit a social media platform from intentionally banning a user for certain reasons including political ideology, viewpoint discrimination or personal animosity. Social media companies could

still restrict access to certain material that was considered to be obscene, lewd, excessively violent, harassing or otherwise objectionable as described by Section 230 of the federal Communications Decency Act, Powers added. The legislation would also require an operator of a social media platform to obtain a certificate to operate as a social media common carrier from the Tennessee Public Utility Commission. If an operator is found to have wrongly banned a user, the commission could fine the social media company \$25,000 or \$100,000 a day until they correct the issue. The fine amount would depend on if the user was a candidate for public office. The operator's certificate could also be suspended or revoked. House Bill 2369 will now go to the House Finance, Ways and Means Committee for additional consideration.

Tennessee Food Freedom Act passes House - The House passed the Tennessee Food Freedom Act this week which removes unnecessary and anti-competitive regulations on homemade food items. House Bill 813 recognizes the right of individuals to produce, procure and consume homemade foods of their choice. Present law requires a person to have a license from the Tennessee Commissioner of Agriculture in order to manufacture, process, pack, or hold food for introduction into commerce. However, present law provides that a license is not required for certain conditions or when food is not potentially hazardous or subject to permit requirements governing dairy foods, poultry or meat processing, or permits for retail food establishments.

House Bill 813 defines a "homemade food item" as items that are produced and packaged at the private residence of the producer. The bill requires homemade food items to be labeled with the name, home address and telephone number of the producer along with the ingredients in descending order of predominance.

Noah's Law to expedite Amber Alerts in certain cases - Following a nationwide manhunt for a missing Sumner County 3-year-old last year, Tennessee lawmakers this week approved

legislation that allows for an Amber Alert to be issued faster in certain cases. House Bill 2354 also known as Noah's Law, allows a custodial parent to seek an emergency court order declaring their child to be in imminent danger if the child is not returned by their non-custodial parent in accordance with a current visitation order or parenting plan. "The ruling could expedite the Amber Alert process for certain cases", according to House Majority Whip Johnny Garrett, R-Goodlettsville, who sponsored the bill. In order to be declared in imminent danger, a child must have been reported as missing and 48 hours have passed without contact from the non-custodial parent or the return of the child, according to the bill. There must also be a pending custody, parentage, child support, or dependency and neglect proceeding in court.

The legislation is named after Noah Clare, of Gallatin, who went missing after his non-custodial father failed to return him

following a scheduled visit in November. The child was found safe in California later that month. However, it took more than a week for an Amber Alert to be issued since the case did not initially meet the imminent danger threshold. Noah and several members of his family were in attendance when the new law was unanimously approved by the House chamber on Monday, March 21. The Senate approved the bill earlier this month. The legislation does not limit the authority of a law enforcement agency to investigate a report of a missing child, notify local media about a missing child or issue any form of missing child alert. House Bill 2354 will now go to Gov. Bill Lee's desk to be signed into law.

Half of Tennesseans Want "Zero Tolerance" Law On Drinking And Driving

The NHTSA reports that across the United States, nearly 30 people are killed each day in drunk-driving accidents, which equates to roughly one preventable death every 50 minutes due to irresponsible driving. Despite the legal consequences of drunk driving, it appears that so long as alcohol is legal and people drive cars, there will be incidents that involve intoxicated road use - with some, unfortunately, resulting in fatalities. The federal limit to legally operate a vehicle in the US is a 0.08% blood alcohol content, however in 2018, the state of Utah implemented the strictest blood-alcohol driving limits in the country dropping from 0.08% to just 0.05% blood or breath alcohol concentration.

DesertHopeTreatment.com conducted a survey of 3,445 people to determine how they feel about implementing a statewide 0% drinking and

driving tolerance policy and found that almost half (42%) of Tennesseans support the idea - this compares to a national average of 33%. On a national level, women are far more supportive of this idea with 40% agreeing compared to 28% of men.

Any amount of alcohol in the system reduces the skills necessary for safe driving, including impaired judgment, vision, color distinction and reaction time. With Utah's 0.05% BAC limit, the NHTSA compared data from the last full year before the legislation was passed and the first year in which the lower legal limit was in place. This comparison showed that Utah had a reduced traffic fatality rate by 18.3% and there were 19.8% fewer fatal accidents in 2019 even though drivers logged more driving miles.

The survey also discovered that a significant portion of respondents do not believe

drunk driving penalties are harsh enough with 66% agreeing that this is the case. And, reassuringly, 3 in 4 said they would report a friend or family who decided to drive drunk.

Worryingly, it was found that more than 1 in 4 (28%) respondents believe it's worse to use a cell phone while driving than it is to drive while under the influence. Distracted driving in any way, shape or form poses a direct risk to the driver their passengers, as well as other vehicles and pedestrians on the road; in 2019, more than 3,100 lost their lives. Using a phone detracts the driver's attention away from the road much in the same way, intoxicated driving affects the driver's mental state. In both circumstances, the driver loses the effectively focus on the road. Another concerning find from the survey revealed that 33% of respondents said they weren't aware of the 0.08% BAC figure to legally drive a car.

There is no definitive answer on how long it takes for a person to metabolize alcohol and reach a state of total sobriety, and driving after a night of drinking is highly discouraged. It is imperative to remember that driving with a BAC at any level presents a serious risk to yourself and every other person on the road. Getting behind the wheel at any level of intoxication should not happen and is something that can be avoided via a number of available alternatives. It is wise to make plans regarding transportation prior to a night of drinking or have some other plan in place that would prevent anyone who is intoxicated from operating a vehicle.

Excessive drinking causes a host of other issues besides eliminating a person's ability to drive safely. If drinking in this manner is a common occurrence, it may be time to re-evaluate your relationship with alcohol or seek the help of a qualified addiction professional.

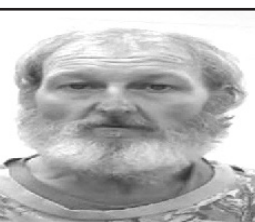

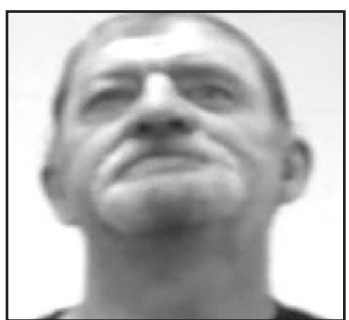

Police Department stated that Murry acquired and transported 4.7 ounces of marijuana, allegedly concealing the marijuana on her person with the

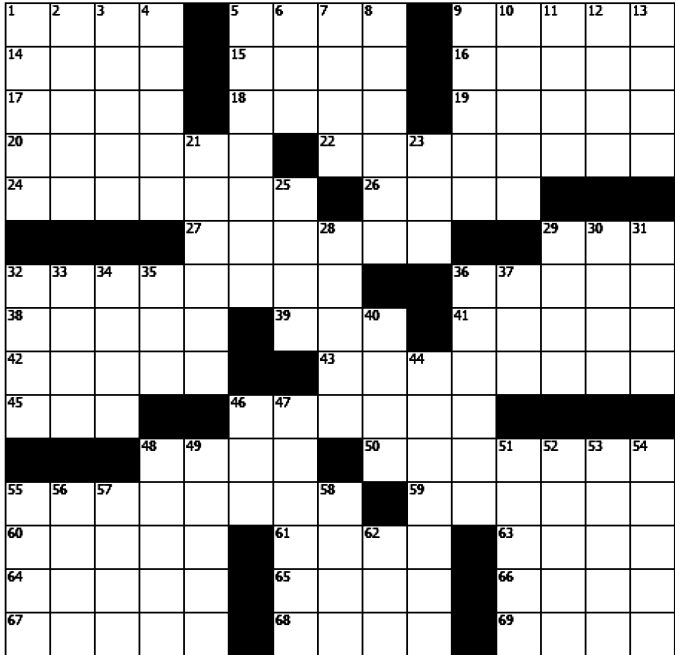
intent to deliver it to a state inmate at South Central Correctional Facility. She was arrested and booked into the Wayne County Jail on \$75,000.00 bond.

Bids for HVAC in the CMS and WMS gyms were next. Superintendent Davis said that no bids were received for this.

Transportation Supervisor Tracy Love next addressed the board regarding the purchase of a new school bus. He requested purchasing one 66-passenger bus off the Sourcewell bid platform. The bus would be purchased from Cumberland International for \$98,425.29. Sherman Martin made a motion to purchase the bus, and Camryn Eaton seconded. The motion passed unanimously on roll call vote.

Superintendent Davis next informed the board that USDA had notified the district that the waiver providing free meals to all students would expire June 30, 2022. All students not receiving free or reduced meals will have to pay full price during the 2022-23 school year. Camryn Eaton inquired about other districts continuing to provide free meals, and the superintendent said he would get more information.

Next under new business, Superintendent Davis announced that the district had been identified as a Reading 360 district. This designation was due to the participation in Early Reading training last summer and utilizing TDOE resources to ensure students develop strong phonics-

based reading skills.

Athletic recognition was next, with Superintendent Davis recognizing the following sports teams: CMS Girls' Basketball, James C. Haile State Champions; WMS Girls' Basketball, James C. Haile State Runner-Up; WMS Boys' Basketball, James C. Haile State Champions; WCHS Girls' Basketball, TSSAA State Tournament Class A Runner-Up; and WCHS Cheerleaders, TSSAA Class A Spirit Award winners. Superintendent Davis expressed appreciation for the athletes, coaches, cheerleaders, and parents for their efforts.

The superintendent next recognized Greg Eaton for his past service on the board. Eaton recently moved out of his district and resigned from his seat on the board.

A concerned parent addressed the board next regarding the vacancy of the nursing position at Frank Hughes School along with nursing pay in general, and discussed a recent incident concerning her child. No action was taken by the board.

With no further business to come before the board, Sherman Martin made a motion to adjourn. Camryn Eaton seconded, and the meeting was adjourned.



Gear up for Gardening

Research shows that cultivating plants is beneficial for us. Gardening has been associated with improvements in attitudes toward health and nutrition and better school performance for kids. Gardening can be a great way to enjoy being outside, get exercise, and grow fruits and vegetables.

Benefits of Gardening and Safety Tips:

• **Fruits and vegetables** - more matters. Gardens can motivate children to try new fruits and vegetables, and kids are eager to taste the 'fruits' of their labor. Fruits and vegetables are an important source of vitamins and minerals, provide fiber, color and texture, and may reduce disease risk, but few children or adults eat recommended amounts. Gardening with your kids will get them excited about the plants on their plate.

• **Increase physical activity.** Light gardening/yard work is considered moderate physical activity. The Centers for Disease Control and Prevention (CDC) suggest gardening as a way to get some of the 2 1/2 hours of recommended weekly activity. If you have been inactive, start out gradually each day, building up time and intensity.

• **Grow a successful garden.** According to the National Gardening Association, the best way to launch a successful garden

is to start small and choose varieties that do well in your area. You might start with vegetables your children already enjoy.

• **Gear up for gardening with safety.** Wear safety goggles, sturdy shoes, and long pants when using lawn mowers or other machinery. Wear gloves to lower the risk for skin irritations, cuts, and certain contaminants and protect your hearing when using loud machinery. Lower your risk for sunburn by wearing long sleeves, wide-brimmed hats, sun shades, and sunscreen.

• **Stay hydrated.** As the gardening season progresses, it's important to be smart about staying hydrated when temperatures are on the rise. Drink plenty of water throughout the day to replace lost fluids. Sipping throughout the day is better than saving up for meals or breaks.

• **Take breaks.** Take breaks often and rest in shaded areas. Stop working if you experience breathlessness or muscle soreness. Signs of heat-related illness include extremely high body temperature, headache, rapid pulse, dizziness, nausea, confusion, or unconsciousness.

Gardening can have a positive impact on eating habits, physical activity level, and overall well-being. Whether you are a beginner or expert gardener, health and safety are always important.

• The supplement should contain either magnesium oxide or magnesium sulfate (not magnesite or dolomitic limestone).

• Generally, loose mixtures are preferred in situations where there is a history of grass tetany, but blocks may be "OK" in low-risk situations.

• Keep hay available until cattle completely stop consuming it.

• A supplement containing cereal grains will provide the energy that cattle need to overcome energy deficits and may help prevent grass tetany.

• After starting cattle on high-magnesium supplements, continue until "danger" is past in the late spring.

• Commercially prepared mixtures typically provide the entire mineral profile which is critical during the rebreeding period.

While this is the most common time we see grass tetany, there are other potential causes of this disease, including: when Mg levels are low due to applying potash and nitrogen fertilizers combined with lush growth, low energy intake, transport stress, low intake of phosphorus and salt, and grasses grown on leached sandy soils. (Information adapted from UT Publication w789)

Grazing Consideration 2: Utilize Crabgrass to Repair Hay Feeding Areas

All winter long your animals have been adding to the nutrient load of your hay feeding areas. The nutrients in your hay are also adding to the nutrient load in the soil. With the cost of fertilizer and other input costs being so high, making plans to repair those hay feeding areas with forage may be a wise investment by utilizing the nutrients deposited in the soil.

One easy way to repair those feeding areas and maximize forages is to seed crabgrass in May. UT has been researching this practice at one of our research stations.

Preliminary findings at our station as well as on producer farms has shown that Crabgrass provides excellent forage mass. With the addition of a residual chemical control, such as GrazonNext, test plots yielded on average 6 tons/acre with only about 14% weed pressure in our research demonstrations. A multiple producer study in Marshall County showed a "conservative yield of 2 tons/acre and forage value at \$80/ton, the potential benefit of repairing these hay feeding areas is a gross of \$160/

acre." (J. Anim. Sci Vol. 100, Suppl. S1)

Currently UT is studying using these areas for hay production. Preliminary findings are showing that crabgrass seeded into hay feeding areas are providing excellent yield and decent quality. This study is being repeated at the station as well as by producers.

Another benefit of Crabgrass is that this forage will fill the forage mass when our cool season grass production decreases in the summer months. If allowed to go to seed, crabgrass will reseed itself, which helps to reduce the overall cost of utilizing this forage species.

To repair hay feeding areas, start by disking or smoothing out the surface of the hay feeding areas to ensure seed-to-soil contact. Then, broadcast 3 to 5 pounds of pure live seed per acre in May.

Budget amendments were next on the agenda. Commissioner McDonald made a motion to approve the amendments from each department as presented before the Budget Committee. Commissioner Powell seconded, and the motion carried unanimously. Commissioner Kelley made a motion to approve the Debt Obligation Resolution. Commissioner Prater seconded, and the motion carried unanimously.

County Executive Mangubat next informed the commission that the Water Board Committee will meet on April 7 at 6:00 p.m. in the City of Collinwood.

An update on the Ag Center was next on the agenda. Mr. Jeff Minatra stated that the site is being prepared for concrete and plumbing.

Surplus property was next on the agenda. Commissioner Kelley made a motion to approve the surplus property as presented from the Clerk & Master's office, and Commissioner Powers seconded. The motion carried unanimously. Commissioner Kelley then made a motion to approve the sale of surplus property from the Circuit Court Clerk's

office. Commissioner Powell seconded, and the motion carried unanimously.

Next, Sheriff Shane Fisher came before the commission. Following a brief discussion, Commissioner Kelley made a motion to approve the grant funding from the state that will pay deputies for highway safety overtime. The grant from the state is in the amount of \$10,000, with a zero match from the county. Commissioner Martin seconded, and the motion passed unanimously.

Sheriff Fisher went on to report that the School Resource Officers have complete the certification course.

Commissioner Powers next made a motion to approve the Broadband Resolution. This resolution is to provide more and better broadband service for the county. Commissioner Brewer seconded, and the motion was passed unanimously on roll call vote.

Commissioner Reeves then nominated Amanda Van Fleet to fill the 7th District School Board Member vacancy. Commissioner Kelley made the motion that nominations cease and that Amanda Van Fleet be elected by acclamation. The motion passed.

Commissioner Kelley next made a motion to sell the tax sale property as listed on the courthouse steps. Commissioner Powers seconded the motion, and it passed unanimously on roll call vote.

Wayne County JECDB Director Rena Purdy came before the commission next, beginning with a discussion regarding electrical utilities at the new Forestry classroom. The fees are to be partially funded by the Board of Education and the County General Fund. There was also a brief discussion concerning the property deed of the Forestry classroom facility being deeded over to the Board of Education from the county.

Highway Superintendent Chuck Moser gave a brief

update on his department, stating that the bridge on Cromwell Ridge Road is almost completed and should be re-opened within the next two weeks. He also reported that paperwork is being processed regarding the bridge on Double Branches.

Commissioner Kelley made a motion to approve the Solid Waste Annual Progress Report. Commissioner Reeves seconded, and the motion carried unanimously.

Solid Waste Director Robert Hayes stated that the tire fee charge was set at 10% above the cost of the county charge for disposal, and that fee would most likely be changing due to the rate increase for the county. He said that the Solid Waste Department would let the commission know when the changes are made.

A cash flow report from Boyd Cottages was presented to the commission. Boyd Cottages Director Gina Skelton was unable to attend the meeting due to being short staffed at the facility.

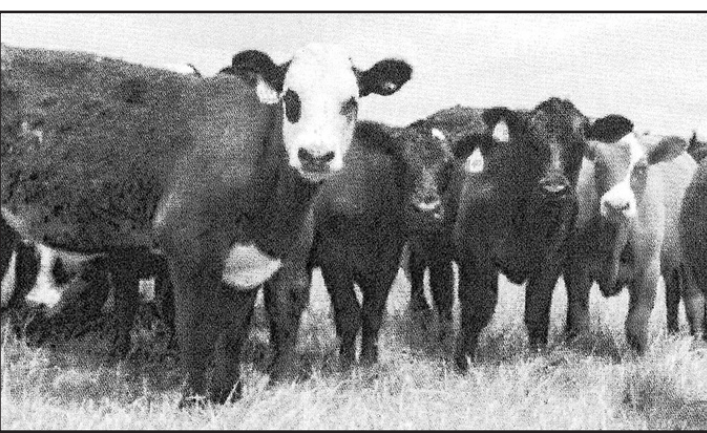
County Executive Mangubat stated that he sent a letter to Lincoln Brass/Mueller concerning the request of a facility clean-up when operations are complete at the location.

Grazing Consideration 1: Grass Tetany

Spring is here and lush grass growth is right around the corner. With that quick growth comes the potential of grass tetany in our cattle.

Grass tetany is a highly fatal disease associated with low levels of Magnesium (Mg) in the blood. One potential cause of grass tetany is from grazing lush forages at green-up that are full of moisture and potentially diluted of minerals. Grass tetany can affect all classes of cattle, but older cows with calves on their side during Mid-February to Mid-April are most at risk. Producers should offer high-magnesium mineral supplements to their cattle to avoid grass tetany, especially if they have lactating animals.

Some general guidelines for supplementing magnesium, taken from "Mineral Nutrition of Beef Cattle" (UT Extension PB 1749), can be found below:

• Provide least 1 oz. per day of magnesium oxide to yield at least 0.6 oz. of magnesium.

• Sighting devices including scopes are legal. Night vision, infrared, and other devices using artificial light to locate wildlife are illegal.

• A pre-charged pneumatic gun (Airbow) that shoots an arrow is legal for all hunters to use during Spring state-

wide turkey season.

Spring Turkey On WMAs

• The use of any type of food to feed or attract wild turkeys on WMAs is prohibited. Calling or attempting to call wild turkeys using any means to mimic the sounds made by turkeys is prohibited on all WMAs from March 1 until the opening day of the spring turkey hunts on the WMA.

Statewide Spring Young Sportsman Hunt

• Ages 6-16. One (1) bearded turkey per day, which counts toward the statewide bag. Each young sportsman must be accompanied by a non-hunting adult, 21 years of age or older, who must remain in a position to take immediate control of the hunting device. Youth 10 years of age or older must meet Hunter Education requirements. Multiple youths may be accompanied by a single non-hunting adult, who is not required to have a license.

New Seabin Devices Will Clean The Tennessee River



The Tennessee Department of Transportation (TDOT) has teamed up with Keep the Tennessee River Beautiful (KTRB) and other partners to establish a network of Seabin automated litter and debris removal devices across the Tennessee River watershed. Seabin devices work continuously to skim and collect marine debris from the surface of the water. Each receptacle can remove up to 3,000 pounds of marine debris a year and will also filter out gasoline, oils, and microplastics from the water. The 17-Seabin deployment will be the world's largest network of such devices in a river system.

The network was made possible through grants from TDOT and Keep America Beautiful (KAB). TDOT's contribution includes the purchase and installation of ten devices at locations throughout Tennessee, as well as funding for two years of water-based cleanups of the river and its tributaries within the state. The grant

was made in conjunction with the Department's "Nobody Trashes Tennessee" litter prevention campaign.

"TDOT's partnership with Keep the Tennessee River Beautiful demonstrates the link between roadside litter and debris that ends up in our waterways," said TDOT Commissioner Joseph Galbato. "Investing in this substantial network of litter removal devices is another example of how TDOT promotes innovative solutions to making our state cleaner and keeping our waterways clear."

In addition to the Tennessee Seabins, two devices will be installed on the Tennessee River in Alabama, and another will be deployed on a tributary in North Carolina. The Seabin network features the following locations: Clifton RV & Marina in Clifton, TN; Tellico Marina & Lake in Vonore, TN; Louisville Landing Marina in Louisville, TN; Volunteer Landing Marina in Knoxville, TN; Tennessee Aquarium in

Chattanooga, TN; Harrison Bay State Park in Soddy Daisy, TN; Pickwick Landing State Park in Hardin County, TN; Paris Landing State Park in Henry County, TN; Lake Ocoee Inn & Marina in Benton, TN; Fontana Village Resort & Marina in Fontana, NC; Joe Wheeler State Park in Rogersville, AL; and Florence Harbor Marina in Florence, AL.

"Until now, all of our work has only been able to prevent microplastics in our waterways, so we are thrilled to be making an effort to actually mitigate microplastics out of the water," said Kathleen Gibi, Executive Director for KTRB. "We're grateful to TDOT and Keep America Beautiful for these—as I see it—revolutionary grants and to our partners who will be maintaining the Seabins to make this trailblazing project

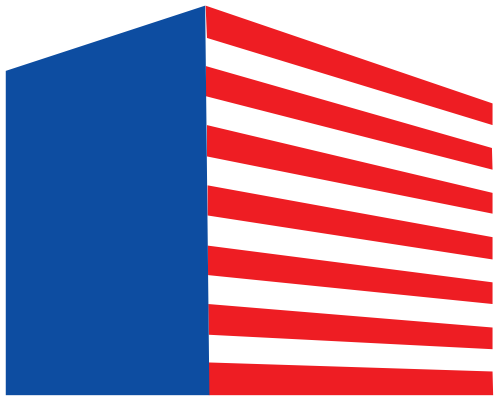
